 - All funding (base, differential and targeted for specific initiatives) is to the jurisdiction, not the schools. This is the most common misunderstanding about "small school by necessity".
 - Golden Hills School Division finances are thoroughly audited annually by an independent third party and monitored by the Ministry of Education. The Audited Financial Statement is posted to the website.
 - Alberta Education states emphatically that the Fraser rankings are an inappropriate and misleading use of data. Students in private, exclusive schools should not, for example, be compared to students from very dissimilar contexts.
