The Board of Trustees approves to appoint Kristy Polet as the Substitute Returning Officer for the purpose of conducting the School Board Trustee Elections for the 2025 Election year.

The Board of Trustees approves Golden Hills School Division to enter into Joint Election Agreements with towns and municipalities that are in our jurisdiction, if a Board of Trustees Election is warranted.
