# May 27, 2025, Regular Meeting of the Board of Trustees

#### 1. Chair's Report

Chair Huntley reported on correspondence received and meetings attended.

## 2. Bylaw 04/2025 – Establish Voting Hours

The Board of Trustees gave first, second and consent for third reading of Bylaw 04/2025, passed unanimously. Bylaw 04/2021 was rescinded and replaced with 04/2025.

## 3. Bylaw 05/2025 - Establish Voting Stations

The Board of Trustees gave first, second and consent for third reading of Bylaw 05/2025, passed unanimously. Bylaw 05/2021 was rescinded and replaced with 05/2025.

### 4. Locally Developed/Acquired Courses

Superintendent Grimsdale reviewed the Locally Developed/Acquired Courses with the Board of Trustees. The Board of Trustees authorized the use of the courses.

## 5. Education Plan and Budget

The Board of Trustees reviewed and approved the Education Plan 2025-2028 and annual Budget 2025/2026 for submission to Alberta Education on May 31, 2025.

#### 6. Budget Submission 2025-2026

The Alberta Government announced a deadline extension of June 20, 2025. Secretary Treasurer Sabir presented information on draft 2025-26 Budget. The Board of Trustees approved the 2025-2026 Budget that will be submitted to Alberta Education by June 20, 2025.
